Notes from Fountain Lakes Master Association President

Residents who sent in their proxy requested a financial audit take place for 2023.

The proposal for a new wall received 80 "yes" votes while 314 voted "no".

Abbiati Dental Update:

The Fountain Lakes Community Association Board met with our Attorney Molly Maggiano and Davidson Engineering on March 1st, 2023 to discuss a course of action regarding the Abbiati Dental Project. The board secured the services of Davidson Engineering and discussed various issues that should be addressed.

February 2nd, 2023, The Abbiati Dental Group submitted an update of their Development Order to the VILLAGE OF ESTERO PLANNING ZONING AND DESIGN BOARD. March 3, 2023, the Village responded to the Abbiati Group with a letter stating the updated Development Order as presented was not approved. The Village cited several topics that need to be addressed.

The VILLAGE OF ESTERO PLANNING ZONING AND DESIGN BOARD comments that concern Fountain Lakes the most are:

- 1. The easement agreement with Fountain Lakes Community Association, Inc. dated March 6th, 2001, appears to be specific to the paved roadway for ingress/egress and underground utility lines. The Application proposes a sidewalk in the easement which is not clearly included in the easement. It is also not consistent with zoning Resolution Z-09-039.
- Please modify the area north of the keypad to 24' width. The proposed 20' does not meet the Village's standard widths. Please revise accordingly. Applicant is requesting approval for 2-10' wide lanes. This could be approved by Administrative Deviation, Right-of-way width specifications for privately maintained roads. Please provide written approval from the Fountain Lakes HOA which owns and maintains the road to change the current 12' lanes to the proposed 10' lanes. [2-506C2A].
- Please provide a copy of the SFWMD permit modification for this Application. Provide a copy of the approved Environmental Resource Permit by the South Florida Water Management District (SFWMD). The SFWMD plans must be consistent with the plans proposed in the Development Order.

The VILLAGE OF ESTERO PLANNING ZONING AND DESIGN BOARD, in accordance with Section 166.033 of Florida HB7103, will allow Abbiati to redraft and submit the required documents (showing the corrections for specified deficiencies) to the Community Development Director within *30 days of the date hereon (March 3, 2023) or request an extension of time to resubmit the documents.

Bonita Spring Utility also submitted the following to Banks Engineering regarding the Abbiati Plan; "The construction plans for the aforementioned project have been reviewed by BSU. The request for construction approval is being withheld based on the comments in the letter."
