## Notes from Fountain Lakes Master Association President

Your Community Association Assessment is due the 1st of January, April, July, and Oct each year. You pay the fee to your Neighborhood Association. They in turn pay the Master Association their share. There is a 10-day grace period after which your account will be charged a late fee. Interest may accrue if the late fee is not paid.

The increase in your association fee which takes effect January 1st 2024. If you do not attend your Neighborhood Budget meeting or receive the mailing, Contact your neighborhood Association President for the new amount of your assessment fee.

I read a USPS policy change that requires proof of identity to change your mailing address. I am not sure how that will affect seasonal residents who forward their mail. It is best to verify with your local post office. It is your responsibility to stay on top of your HOA payment. Do not rely on the post office to deliver your invoice on time. You may set up ACH payments with Pegasus to make your life simpler.

## Covenant Coaching

"Covenant Coaching" for the benefit of our newer residents and a refresher for those folks who have been busy with life in "Paradise" and may appreciate a reminder. Fountain Lakes has always been a deed restricted community. Abiding by the Convenances protects the value of our property and the integrity of our neighborhoods.

Please note Amended and Restated Declaration of Covenants and Restrictions:

"Committed Property" homeowners' property.

"Corporate Common Property" Association property such as roads, Cul-de-Sac, and club house area.

Call before you "DIG" - https://www.sunshine811.com/law#104

It is a Florida Law that you locate utilities before you dig. Even is you are just planting a tree or shrubbery in your yard, you need to be aware of where underground utilities are located.

You are required to fill out an Architectural Review Form (ARC) when upgrading your landscape. You are prohibited from planting over property line, drainage easements, and utility areas.

Amended and Restated Declaration 2020

4.22 <u>Landscape.</u> An Architectural Review Form must be filed and approved by the Corporation for any landscaping change. A copy of the plot plan must accompany all changes to Landscape. Hand drawn plans are permissible. Trees and shrubbery may not be planted over property lines, storm sewers, utility lines or swales. No exotic, invasive or poisonous trees or shrubbery are allowed. All dead trees shall be removed within 60 days. Homes adjacent to lake banks require a 25-foot setback from the high-water line for any
